## WYCOMBE DISTRICT COUNCIL (OFF-STREET PARKING PLACES) (VARIATION) ORDER 2020

WYCOMBE DISTRICT COUNCIL ("the Council") in exercise of their powers under sections 32, 33, 35, 35A and s35C and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hererinafter referred to as "the Act") and all other enabling powers, after consultation with the Chief Officer of Police for the County of Buckinghamshire in accordance with Part III of Schedule 9 of the Act hereby direct as follows:

- 1. This Order may be cited as Wycombe District Council (Off-Street Parking Places) (Variation) Order 2020 ("the Off Street Order 2020") and shall come into force on 20 January 2020.
- As from the date upon which this Order comes into operation, the provisions of the Wycombe District Council (Off-Street Parking Places)Order 2019 shall be varied as follows:
- (a) the following car parks shall be added to Schedule 1 and the enforceable boundary of the car parks added to Schedule 2 to reflect the rules pertaining to those locations:
